2010-2011 Financial Policy Information

ANNUAL FEES

- \$350 – Registration Fee (K through 10th Grade)
- \$190 – Screening and Assessment Fee (One time fee paid directly to SES)

REGISTRATION – Policies

1. All students, without exception, must pay registration fee.
2. Registration/Materials fees are non-refundable and non-prorated, except for non-acceptance by the School. (Refer to our Refund Policy for details.)
3. All registration fees for new and re-enrolling students are due with the submission of the application.
4. Re-enrolling students must pay the registration fee by January 29th in order to guarantee placement for the following year.

TUITION – Fees

Elementary School: (K through 5th Grade) – \$6200 / year

Middle School: (6th - 8th Grades) – \$6800 / year

High School: (9th - 10th Grades) – \$7400 / year

(Tuition includes all textbooks, but does not include lunch, extended care, field trips, sports participation fees, and lab fees.)

TUITION – Policies

1. Tuition payments are handled by FACTS Management **e-Cashier**. Through **e-Cashier**, parents can set up Automatic Bank Payments from their Checking, Savings, or Credit Card accounts. Tuition may be set up to be handled as:
 - a. Monthly payments (10 month or 12 month increments)
 - b. Semi-Annual payments
 - c. One Annual payment
2. A \$25.00 fee will be charged if you do not have sufficient funds in your bank account or on your credit card on the day the transaction is attempted.
3. If a child is withdrawn before the end of the school year, tuition must be paid until the end of the semester (January and June).
4. Lake Norman Christian School is a non-profit organization completely dependent upon tuition and donations as its principle source of income. Parents are responsible for prompt payment of all outstanding tuition and fees. Report cards and student records cannot be issued if a student has an outstanding balance on his/her account. These items will be released once all accounts have been brought current.
5. Students may be asked to withdraw if payment is currently late.

REGISTRATION FEE REFUND POLICY

The policy for refunds of registration fees will be as follows:

- If your child does not test into the program, you will receive a full refund.
- If your child tests in to the program, but is on the waiting list and you decide to withdraw them prior to December 17, 2010, before they are offered a position, you will receive a full refund. Refunds will be given to those who are not placed in a position by December 17, 2010.
- If one of your children tests in to the program, but another does not and you wish to place them both at another school together, (before the school year starts) your registration for both will be refunded in full.
- If you move at least 30 miles away from the location of the school before the school year starts, your registration fee will be refunded.
- Once your student attends school, there are no refunds issued.
