The SES, Inc. staff members are looking forward to providing applicant testing services for your child. In order for the evaluation process to be completed in an orderly manner, please read carefully the following information:

The applicant testing fee is **\$190.00** for the **2010-2011** school year. Payments may be made by **check** or **VISA/MasterCard**.

- If payment is made by **check**, checks must be mailed to **SES, Inc., 2101 Sardis Road North, Suite 216**, Charlotte, NC 28227 along with the attached client information sheet.
- Check must be written to SES, Inc.
- Within 2 business days of your check and client information sheet being received, you will be contacted to schedule the next available appointment.
  
- If payment is made by **VISA or MasterCard**, contact the SES, Inc. staff at 704-517-2836 or send an e-mail to [kayses04@aol.com](mailto:kayses04@aol.com) with your contact information
- Within 2 business days of your message being received, you will be contacted to schedule the next available appointment and make payment by phone
- The attached client information sheet should be completed and brought to your child's appointment

**Read carefully the following information:**

- All tests are individualized and untimed; therefore, the length of the testing session may vary from child to child. Allow 2-3 hours per testing session, and small breaks are permitted in relation to age/grade.
- It is important that you arrive to the office 15 minutes prior to your scheduled time. Please allow for appropriate travel time.
- This evaluation will include cognitive and academic assessments. Evaluation results (scores) will be mailed to you and to the admissions office at Lake Norman Christian School within 10 business days of your child's testing date.
- The SES, Inc. staff will not determine acceptance of your child's application.
- Test results are based on age, not grade placement
- Marcia Bruschi, M.Ed. will be administering the evaluation. She will be available for testing beginning January 2010 and continue until September 2010. However, our offices will be closed for summer vacation June 24<sup>th</sup> - July 6<sup>th</sup>.
- If you should need to reschedule, please call 704-517-2836 within 24 hours of your scheduled time. A processing fee of \$50.00 will be required for re-scheduled or cancelled appointments.

2. Take exit 11 A Brookshire Freeway East

4. Turn right onto Sardis Road North go 0.5 miles
5. 2101 Sardis Road North is on the right
